**M** Describe the steps you intend to take to promote the four licensing objectives:

**a) General – all four licensing objectives (b, c, d and e) (please read guidance note 9)**

We have a clear structure in place in order for delegation of responsibilities, a full emergency plan and site policies.

**b) The prevention of crime and disorder**

The festival will have stewards and SIA registered security staff to deal with potential crime and disorder issues. The SIA registered staff will be on the main entrance with spot checks and searches. The registered staff will also be in the bar area as well as doing scheduled walk rounds. Stewards will be at control points on stages and general exits.

**c) Public safety**

The festival has used guidance from HSE195 ensuring we have first aid provisions and detailed plans of the site in the event of any emergency. We also have crowd safety barriers and clear signage at exits. All access to backstage areas are kept away from the public and stewards and SIA staff will follow briefings on incident and accident reporting.

**d) The prevention of public nuisance**

The festival works closely with Stradbroke Parish Council to ensure the smooth running and communication to the general public. We strive to work together with immediate neighbours in order to prevent public nuisance. We have agreed to end all music at the reasonable time of 22:30 hours and have arranged for the local pub to encourage people to their premises after the event. Stewards and security will clearly be identifiable and SIA approved staff will be wearing badges.

**e) The protection of children from harm**

The festival has insisted that all children under the age of 14 must be supervised by an adult, however in the event of a lost child a strict policy is in place with a lost children point at the first aid station. All staff will be fully briefed on the lost child policy.

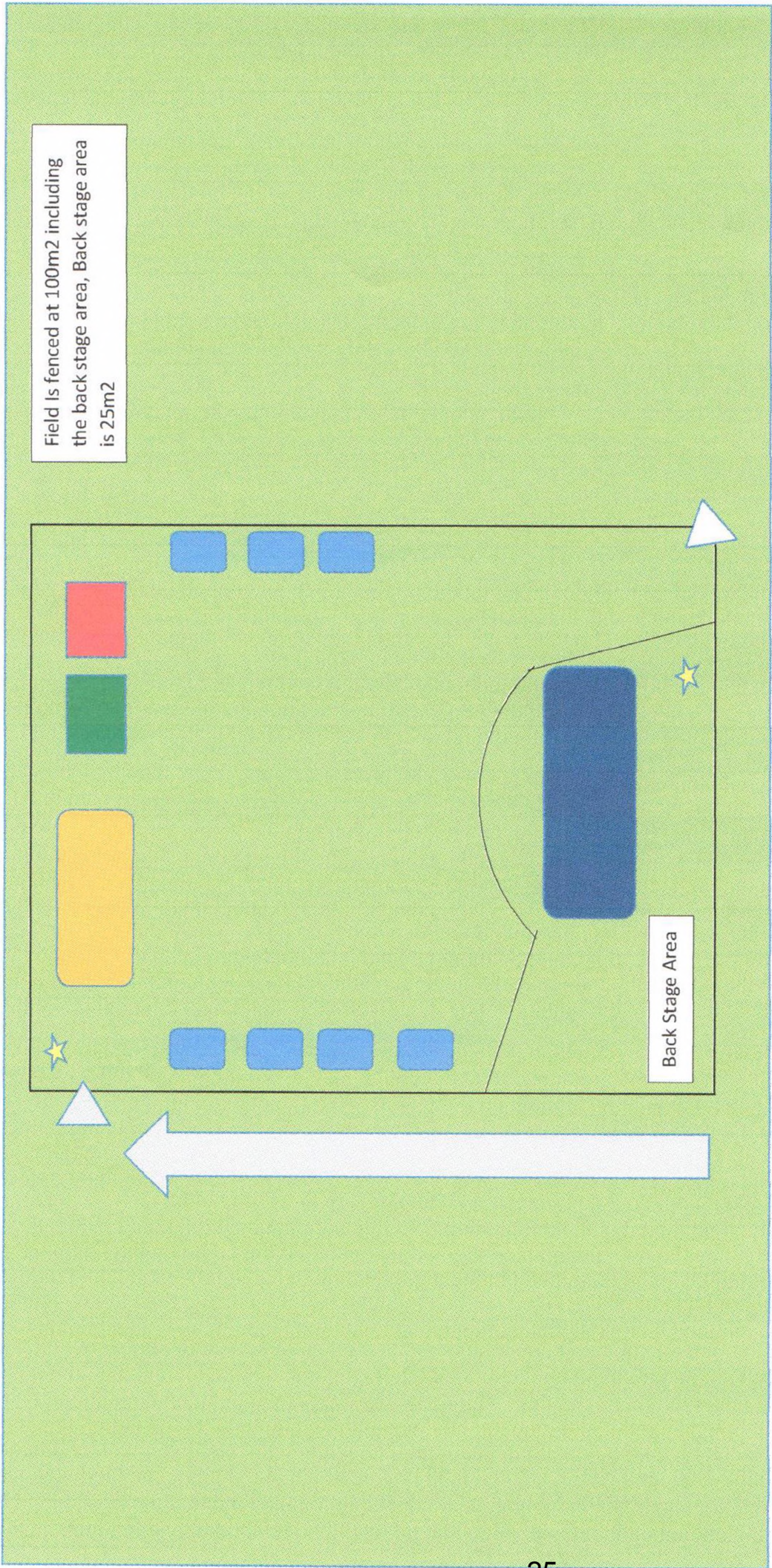
