The court has found that in relation to the address: Maltings Complex, Station Road East, Stowmarket, Suffolk, IP14 1RQ

- || a. A person has engaged in disorderly, offensive or criminal behaviour on the premises;
- b. The use of the premises has resulted in serious nuisance to members of the public;
- || c. There has been disorder near those premises associated with the use of those premises; and
- d. The making of the order is necessary to prevent the behaviour, nuisance or disorder from continuing, reoccurring or occurring for the period specified in the order.

The Court in issuing this Closure Order prohibits <sup>Members of the Public</sup> anyone, other than those specified in schedule 1 below, from remaining on or entering <sup>T. BAR & Carbon at</sup> (Maltings Complex, Station Road East, Stowmarket, Suffolk, IP14 1RQ) at all times and in all circumstances, other than those specified in schedule 1 below.

until the 14<sup>th</sup> July 2015

The Closure Order is in force for a period of 3 months from the date of this Order.


If anyone does anything which they are prohibited from doing by this Order they shall be liable on summary conviction to a term of imprisonment not exceeding 51 weeks or to a fine or both.

Pursuant to section 85 of the Anti-Social Behaviour, Crime and Policing Act 2014 a constable or a person authorised by the Chief Constable of Suffolk Constabulary may use reasonable force to enter (Maltings Complex, Station Road East, Stowmarket, Suffolk, IP14 1RQ); do anything necessary to secure (insert address) against entry; and may also enter (Maltings Complex, Station Road East, Stowmarket, Suffolk, IP14 1RQ) to carry out essential maintenance or repairs.
