### Recommended Motion

Under section 100A (4) of the Local Government Act 1972 the public be excluded from the meeting for item 10 on the grounds that it involves the likely disclosure of exempt information as defined in Part 1 of schedule 12 of the Act on the grounds set out in Regulation 14 (2) of the Licensing Act 2003 (Hearings) Regulations 2005.

*Note: Information is exempt only if:  
It falls within one of the 7 categories of exempt information in the Act and;  
In all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information*

*Categories for agenda item 10*

6. *Information which reveals that the authority proposes-*
  - (a) to give under any enactment a notice under of by virtue of which requirements are imposed on a person; or*
  - (b) to make an order or direction under any enactment*
