Babergh and Mid Suffolk Cabinet Meetings

REASON FOR ACTION BEING TAKEN OUT OF MEETING:

Meetings have been cancelled following general health advice issued in relation to the Corona virus (Covid-19) outbreak. No Cabinet meeting dates are available to take this decision in time to support the Corona virus (Covid -19) outbreak.

The decision has been taken in order to secure the emergency accommodation as detailed below.

BACKGROUND:

On Thursday 26th March, the Government announced that all Rough Sleepers needed to be 'indoors' by the weekend (the following day). The Councils agreed with West Suffolk to work together to try and identify a solution.

Babergh and Mid Suffolk District Councils together with West Suffolk Council have managed to negotiate the exclusive use of a hotel for £7,993 per week for 4 weeks for 18 rooms shared between the Councils.

MHCLG made it clear in a phone call on 27th March that this was a Public Health Emergency and not a Homelessness Issue. Therefore, Public Health will be covering the costs.

FINANCIAL IMPLICATIONS:

The cost for exclusive use of a hotel is £7,993 per week for 4 weeks.
