#### SUBJECT MATTER:

The Chief Executive has specific delegation to take any action, including the incurring of expenditure, in connection with an emergency or disaster in the district as specified in the Constitution; Part 2: Responsibility of Functions

#### **MEETING TO WHICH MATTER RELATES:**

Babergh and Mid Suffolk Cabinet Meetings

#### REASON FOR ACTION BEING TAKEN OUT OF MEETING:

Meetings have been cancelled following general health advice issued in relation to the Corona virus (Covid-19) outbreak. No Cabinet meeting dates are available to take this decision in time to support the Corona virus (Covid -19) outbreak.

The decision has been taken in order to secure the emergency accommodation as detailed below.

### **BACKGROUND:**

On Thursday 26<sup>th</sup> March, the Government announced that all Rough Sleepers needed to be 'indoors' by the weekend (the following day). The Councils agreed with West Suffolk to work together to try and identify a solution.

Babergh and Mid Suffolk District Councils together with West Suffolk Council have managed to negotiate the exclusive use of a hotel for £7,993 per week for 4 weeks for 18 rooms shared between the Councils.

MHCLG made it clear in a phone call on 27<sup>th</sup> March that this was a Public Health Emergency and not a Homelessness Issue. Therefore, Public Health will be covering the costs.

## **FINANCIAL IMPLICATIONS:**

The cost for exclusive use of the hotel is £7,993 per week for 4 weeks.

MHCLG made it clear in a phone call on 27<sup>th</sup> March that this was a Public Health Emergency and not a Homelessness Issue. Therefore, I will be asking Public Health to cover the costs.
