LAC30 MINUTES OF THE LICENSING ACT 2003 COMMITTEE MEETING HELD 4 DECEMBER 2015

LAC34 GAMBLING ACT 2005 – FIXED ODDS BETTING TERMINALS (FOTBS)

The report referred to the issues surrounding Fixed Odds Betting terminals (FOBTs), classified as category B2 gaming machines under the Gambling Act 2005 in betting shops.

Councillor Matthissen advised that he had initially requested the report be brought to the Committee as had concerns regarding the use of the machines for criminal purposes, in particular money laundering. He was also concerned regarding the possible increase in gambling addiction; the machines were out of proportion to other betting shop activities which were moderated in various ways and were located in the District's most deprived area. He supported Newham Council's views and asked that the Council add it's backing to that of the 93 local authorities who had expressed their support.

There was some support for the proposal as it was felt preferable to prevent a problem before it occurred but a motion to approve Recommendation 2.1 was lost by two votes to three.

It was generally agreed that as there was no current problem in the Mid Suffolk District it was not necessary to join Newham Council and the LGA in support of reducing the stakes for FOBTs or to refer the matter to Full Council. However, Members understood and shared the concerns raised and it was agreed that a letter should be sent from the Committee to the LGA to this effect.

That a letter be sent to the LGA on behalf of the Licensing Act 2003 Committee advising that the Committee has considered the issues and share the concerns raised but as there is no particular issue in regard to FOBTs in the Mid Suffolk District feel there is no need to take action at this time
